 - develop the ability to analyze economic arguments and to think critically about their benefits and consequences
- Evaluation: Your performance evaluation in this course will be based on three components
- Three periodic knowledge accumulation and application assessments (45%)¹
 - Knowledge and application retention assessment (25%)
 - Writing evaluation (15%)
 - Take home work (10%)
