<u>Overview</u>: Many contemporary scholars identify several principle areas as fundamental to the field of family law. First, family law addresses issues centered on the formation and dissolution of various family relationships, namely, marriage, divorce and, more recently, procreation and alternative families. Second, family law examines the law that governs the rights, obligations and responsibilities that flow from family relationships, including but not limited to relationships between parent and child, spouses, and other third parties, as well as medical decision-making, neglect and abuse.

Students will have an opportunity to learn how family law and related issues is formed, interpreted and practiced, and to learn how law emerges from the social fibers of our society, attempting to evolve as social standards, mores and technology evolves. Students are expected to read and understand the assignments, using analytical skills of legal reasoning. While some legal education will be helpful, it is not absolutely necessary.

Please note that attendance in class is a vital component if you expect to do well. This is an upper-level four credit course and a lot of ground is covered in each class, since we only meet once a week.

#### Course Requirements:

- 1. <u>Examinations</u>: There will be one mid-term examination and a final examination, based upon all reading assignments, lectures, class discussions, videos and guest lecturers. The mid-term is scheduled for October 14~. The college will schedule the final exam.
- 2. <u>Quizzes</u>: There will he 10 short quizzes, graded as 10 points each, for a total of 100 points. Some will be in class, some take home, some open book, some closed book. Each will be announced in class prior to the quiz date. ANY OUT-OF-

CLASS ASSIGNMENTS TURNED IN LATE WILL RESULT IN AN AUTOMATIC ONE POINT DEDUCTION FOR EVERY DAY THE ASSIGNMENT IS TURNED IN LATE.

- 3. <u>Course Project/Term Paper</u>: The instructions, a set of facts and team assignments will be distributed by the second class and the project is to be completed and turned in by the last class on December 9th. The fact pattern contained in the project will also be used throughout the course for discussion and resolution of potential issues, argument of positions on the issues and application of the law. The fact pattern is susceptible to change as additional information develops throughout the course and if the positions of the parties change (and possibly because parties don't always tell the whole story or disclose pertinent facts).
- 4. <u>Class Participation: This is not strictly a lecture course</u>. It is, therefore, very important for students to come to class prepared to discuss the assigned reading material. Please pay particular attention to the assigned readings as set forth on the Schedule of Classes below. Even though this class meets only once per week, the four course credits given dictate the amount of material to be covered. You should view the one class per week as if we were meeting twice per week. Remember the college rule of thumb \_preparation time for the class should be at least double the amount of class time. BRING YOUR TEXTBOOKS AND ALL HANDOUTS TO CLASS. <u>Remember class participation is 10% of your final grade so, obviously, lack of attendance can result in a poor class participation grade.</u>

Please note that since this is an evening class, daytime college events generally do not result in class being cancelled. 1 will do my best to notify everyone via email in the event class must be cancelled for any reason but do not assume that if daytime classes are cancelled, evening classes are cancelled as well.
