## **Course Objectives:**

This purpose of this course is to introduce students to the language, theory and practice of the law with a particular emphasis on the American legal system as it compares to other legal systems in the world.

- \* We will explore both the criminal and civil justice systems;
- \* You will be introduced to the foundation of the constitutional process and Court structures and procedures;
- \* We will look at the major topical areas of the law; including but not limited to Administrative law; Criminal Law; the law of Torts; Family law, Property law; Employment law and Estates and Trusts.
