COURSE DESCRIPTION:

Family law addresses issues centered on the formation and dissolution of various family relationships; namely, marriage, divorce, and more recently, procreation and alternative families. Second, family law examines the law that governs the rights, obligations and responsibilities that flow from family relationships, including but not limited to relationships between parent and child, spouses, and other third parties, as well as medical decision-making, neglect and abuse.

GOALS OF THIS COURSE:

Students will have an opportunity to learn how family law and related issues are formed, interpreted and practiced, and to learn how law emerges from the social fibers of our society, attempting to evolve as social standards, mores and technology evolves. Students are expected to read and understand the assignments, using analytical skills of legal reasoning. While some legal education will be helpful, it is not absolutely necessary.

COURSE REQUIREMENTS:

Students are expected to be prepared for each class. Inadequate preparation may result in the lowering of the grade for the course!

Testing counts for 50% of the final grade. Each test will be equally weighted.

There will be no unannounced tests. Considerable notice will be given for the date of each of the tests addressed above.

Class attendance and class participation will account for 25% of your final grade.

The final 25% of a student's grade will be taken from weekly quizzes. The requirement will be explained at the first class.

There is no research paper requirement for the course. However, a paper may be done for extra credit. This is optional with the student. Extra credit will be given for a course paper which will be due two weeks before the last class. I expect a well-written and well-research paper of 7 to 10 pages. If a quality paper is submitted with a grade higher than your test average, your grade for the course will be raised. If the grade for the paper is less than the testing average, the grade for the paper will be disregarded and the final grade will be calculated exclusively on testing. If the student opts for the extra credit paper, I will work with the student to decide a topic. If the student chooses to do the paper, he/she must advise me by the mid-point of the course.

ATTENDANCE POLICY:

Regular attendance is fully expected. It is understood that there are circumstances that would prevent a student from attending class (illness, family emergency). The student, in such a case, is expected to notify the instructor as soon as possible of the situation. Students should also check with the instructor regarding missed work or assignments.

ACADEMIC HONESTY:

Any student found to have violated the college's policy shall be dismissed from the course and assigned a grade of F. Students are urged to see the instructor if they have any questions regarding this matter.
