Course Objectives:

The purpose of this course is to introduce students to the language, theory and practice of the law with a particular emphasis on the American legal system as it compares to other legal systems in the world.

- * We will explore both the criminal and civil justice systems;
- * We will be introduced to the foundation of the constitutional process and Court structures and procedure.
- * We will look at the major topical areas of the law; including not limited to Administrative law; Criminal law; the law of Torts; Family law; Property law; Employment law; Estates and Trusts.

Requirements and Methods of Evaluation:

There are four requirements to successfully complete this class:

- * You will be expected to attend and participate regularly in class (See Attendance and Participation Policy below)
- * You will be expected to read the homework assigned to you, whether in the book or by handout.
- * You will be expected to participate in at least one team presentation for which you either volunteer or are asked to present.
